Tujuan dari penelitian ini adalah untuk mengetahui apakah: (1) ada hubungan antara faktor finansial dan minat mahasiswa FKIP menjadi guru; (2) ada hubungan antara faktor sosial dan minat mahasiswa FKIP menjadi guru; (3) ada hubungan antara faktor yuridis dan minat mahasiswa FKIP menjadi guru.

Penelitian ini dilaksanakan di Fakultas Keguruan dan Ilmu Pendidikan Universitas Sanata Dharma. Subyek penelitian ini mahasiswa angkatan 2004 dan 2005 dengan jumlah sampel sebesar 296 mahasiswa. Adapun teknik pengambilan sampel menggunakan *proportional random sampling*. Teknik pengumpulan data yang digunakan adalah kuesioner. Teknik analisis data menggunakan analisis *chi square*.

Hasil penelitian menunjukkan bahwa: (1) tidak ada hubungan antara faktor finansial dan minat mahasiswa FKIP menjadi guru (*chi square* hitung = 1,64 < *chi square* tabel = 9,488); (2) tidak ada hubungan antara faktor sosial dan minat mahasiswa FKIP menjadi guru (*chi square* hitung = 8,15 < *chi square* tabel = 9,488); (3) ada hubungan antara faktor yuridis dan minat mahasiswa FKIP menjadi guru (*chi square* hitung = 11,47 > *chi square* tabel = 9,488).

The aims of the research are to know : (1) the relation between financial factor and the interest of students of Teacher Training and Educational Faculty to become teachers (2) the relation between social factor and the interest of students of Teacher Training and Educational Faculty to become teachers (3) the relation between juridical factor and the interest of students of Teacher Training and Educational Faculty to become teachers.

This research was done in Teacher Training and Educational Faculty of Sanata Dharma University. The samples in this research were 296 students 2004 and 2005 academic year. The technique of taking the samples was propotional random sampling. The technique of collecting data was questionnaire. The technique of analyzing the data was chi square analysis.

The results of the research show that (1) there is no relation between financial factor and the interest of students of Teacher Training and Educational Faculty to become teachers (calculation of chi square = 1,64 < table of chi square = 9,488), (2) there is no relation between social factor and the interest of students of Teacher Training and Educational Faculty to become teachers (calculation of chi square = 8,15 < table of chi square = 9,488), (3) there is a relation between juridical factor and the interest of students of Teacher Training and Educational Faculty to become teachers (calculation of chi square = 11,47 > table of chi square = 9,488).
