Penelitian ini bertujuan untuk mengetahui kemudahan penggunaan persepsi, efektivitas persepsi, dan efisiensi persepsi dari pengguna *e-System* administrasi perpajakan. Penelitian dilakukan di Kantor Pelayanan Pajak (KPP) Pratama Magelang.

Jenis penelitian ini adalah studi kasus. Pengumpulan data dilakukan dengan teknik survei dan menggunakan instrumen kuesioner. Populasi dalam penelitian ini berjumlah 134.078 responden dan terdapat 100 sampel yang ditentukan menggunakan teknik *Convenience Sampling*. Teknik analisis data yang digunakan adalah skala sikap.

Hasil penelitian ini menunjukkan bahwa penggunaan *e-System* administrasi perpajakan menurut persepsi Wajib Pajak Orang Pribadi sangat mudah, penggunaan *e-System* administrasi perpajakan menurut persepsi Wajib Pajak Orang Pribadi sangat efektif, dan penggunaan *e-System* administrasi perpajakan menurut persepsi Wajib Pajak Orang Pribadi sangat efisien.

This research aims to find out the perceived ease of use, perceived effectiveness, and perceived efficiency on e-system taxation administration based on users perception. This research was conducted at Tax Service Office (KKP) Pratama Magelang.
