Penelitian ini dilakukan dengan tujuan untuk mengetahui pelaksanaan pengendalian intern pembelian medis dan non medis di Rumah Sakit Panti Nugroho dan untuk mengetahui keefektifan pengendalian intern pembelian medis dan non medis yang ada di Rumah Sakit Panti Nugroho.

Jenis penelitian yang dilakukan adalah studi kasus pada Rumah Sakit Panti Nugroho. Teknik pengumpulan data yang digunakan adalah wawancara, dokumentasi dan kuisioner. Teknik analisis data yang dilakukan adalah melakukan pengisian kuisioner untuk mengetahui pelaksanaan pengendalian intern pembelian dan melakukan pengujian keefektifan pengendalian intern pembelian medis dan non medis di Rumah Sakit Panti Nugroho dengan menggunakan metode *stop-or-go sampling*.

Berdasarkan hasil analisis data, diperoleh kesimpulan bahwa pengendalian intern pembelian medis dan non medis di Rumah Sakit Panti Nugroho pada prosedur struktur organisasi belum baik , prosedur sistem otorisasi dan prosedur pencatatan serta prosedur praktik yang sehat telah berjalan dengan baik, selain itu pengendalian intern pembelian medis dan non medis di Rumah Sakit Panti Nugroho sudah efektif.
