ABSTRAK

PERBEDAAN MINAT SISWA MELANJUTKAN STUDI DITINJAU DARI SOSIAL EKONOMI DAN PENGETAHUAN ORANG TUA SISWA SMP

Penelitian ini bertujuan untuk mengetahui perbedaan minat siswa melanjutkan studi ke SMA dan SMK ditinjau dari status sosial ekonomi orang tua yaitu: jenis pekerjaan orang tua, penghasilan orang tua, tingkat pendidikan orang tua, jumlah tanggungan orang tua dan pengetahuan orang tua tentang studi lanjut setelah SMP.

Penelitian ini dilaksanakan pada empat SMP di Kabupaten Klaten, yaitu: SMPN 1 Jogonalan, SMPN 2 Jogonalan, SMP Pangudi Luhur 1 Klaten dan SMP Muhammadiyah 17 Prambanan, Klaten. Subjek dari penelitian ini adalah orang tua dan siswa-siswi kelas IX di SMPN 1 Jogonalan, SMPN 2 Jogonalan, SMP Pangudi Luhur 1 Klaten dan SMP Muhammadiyah 17 Prambanan, Klaten. Pengambilan sampel sebanyak 175 siswa menggunakan teknik *simple random sampling*. Pengumpulan data menggunakan metode kuesioner, wawancara, dokumentasi dan tes. Analisis data menggunakan *Chi kuadrat*.

Hasil pengujian hipotesis menunjukkan bahwa: (1) ada perbedaan minat melanjutkan studi ke SMA dan SMK ditinjau dari jenis pekerjaan, tingkat penghasilan dan tingkat pendidikan orang tua; (2) tidak ada perbedaan minat melanjutkan studi ditinjau dari jumlah tanggungan orang tua dan pengetahuan orang tua tentang studi lanjut.

THE DIFFERENCES OF STUDENTS' INTEREST IN CONTINUING THEIR STUDY PERCIEVED FROM SOCIAL, ECONOMICAL STATUS AND KNOWLEDGE OF JUNIOR HIGH SCHOOL STUDENTS' PARENTS

This research aims to observe the differences of students' interest in continuing their study to Senior High Schools and Vocational High Schools percieved from the parents' social economical status which cover: Parents' occupation, salary, level of knowledge, number of family members funded by the parents, and parents' knowledge.

This research was conducted in four Junior High Schools in Klaten, namely 1 State Jogonalan Junior High School, 2 State Jogonalan Junior High School, 1 Pangudi Luhur Junior High School and 17 Muhammadiyah Prambanan Junior High School Klaten. The population of this research was the parents' and the eleventh grade students of those schools. The samples were 175 students taken by using simple random sampling technique. The data were collected by applying questionnaire, interview, documentary study methods, and tested and analyzed by Chi Quadrade.

The result shows (1) there were different interest of the students in continuing their study to Senior High Schools and Vocational High Schools percieved from parents' occupation, salary, and level of knowledge; (2) there were not any different of the students interest in continuing their study percieved from number of family members funded by the parents, and parents' knowledge in continuing their study after Junior High Schools.
