Penelitian ini bertujuan untuk mengetahui: (1) hubungan prestasi belajar mata pelajaran kewirausahaan dengan jiwa kewirausahaan siswa SMK; (2) hubungan jenis pekerjaan orang tua (ayah) dengan jiwa kewirausahaan siswa SMK; (3) hubungan jenis pekerjaan orang tua (ibu) dengan jiwa kewirausahaan siswa SMK; (4) hubungan tingkat pendapatan orang tua (ayah) dengan jiwa kewirausahaan siswa SMK; (5) hubungan tingkat pendapatan orang tua (ibu) dengan jiwa kewirausahaan siswa SMK; dan (6) hubungan tempat tinggal siswa dengan jiwa kewirausahaan siswa SMK.

Penelitian Studi kasus ini dilakukan di SMK Kristen 2 Klaten dan SMK Negeri 1 Klaten pada bulan Maret-April 2009. Populasi penelitian ini adalah siswa SMK Kristen 2 Klaten dan SMK Negeri 1 Klaten yang berjumlah 1.333 siswa. Sampel penelitian ini adalah siswa kelas II Jurusan Penjualan yang berjumlah 175 siswa. Teknik pengumpulan data dengan menggunakan kuesioner dan wawancara. Teknik analisis data dilakukan dengan Uji Statistik Non Parametrik *Chi Square*.

Hasil penelitian ini menunjukkan bahwa: (1) tidak ada hubungan prestasi belajar mata pelajaran kewirausahaan dengan jiwa kewirausahaan siswa SMK; (2) tidak ada hubungan jenis pekerjaan orang tua (ayah) dengan jiwa kewirausahaan siswa SMK; (3) ada hubungan jenis pekerjaan orang tua (ibu) dengan jiwa kewirausahaan siswa SMK; (4) tidak ada hubungan tingkat pendapatan orang tua (ayah) dengan jiwa kewirausahaan siswa SMK; (5) tidak ada hubungan tingkat pendapatan orang tua (ibu) dengan jiwa kewirausahaan siswa SMK; dan (6) tidak ada hubungan tempat tinggal siswa dengan jiwa kewirausahaan siswa SMK.

THE RELATIONSHIP OF LEARNING ACHIEVEMENT OF ENTREPRENEURSHIP SUBJECT, TYPE OF PARENTS' JOB, LEVEL OF PARENTS' REVENUE, AND SETTLEMENT OF STUDENTS WITH ENTREPRENEUR SPIRIT OF STUDENTS IN VOCATIONAL HIGH SCHOOL

This research intends to know: (1) the relationship between learning achievement of entrepreneurship subject and entrepreneur spirit of students in Vocational High School; (2) the relationship between the type of father's job and the students entrepreneurship spirit of students in Vocational High School; (3) the relationship between mother's job and the entrepreneur spirit of students in Vocational High School; (4) the relationship between father's revenue and the entrepreneurship spirit of students in Vocational High School; (5) the relationship between mother's revenue and the entrepreneurship spirit of students in Vocational High School; and (6) the relationship between students' settlement and the entrepreneur spirit of students in Vocational High School.

This case study was conducted in 2 Klaten Christian Vocational High School and 1 Klaten State Vocational High School from March to April 2009. The population of this research were 1.333 students of 2 Klaten Christian Vocational High School and 1 Klaten State Vocational High School. The samples of this research were 175 students of the second Grade of Marketing Department. The techniques of data collection were questionnaire and interview. The techniques of data analysis was Chi Square Non-Parametric Statistical Test.

The result of this research shows that: (1) there is no relationship between learning achievement of entrepreneurship subject and the entrepreneur spirit of students in Vocational High School; (2) there is no relationship between father's type of job and entrepreneur spirit of students in Vocational High School; (3) there is a relationship between mother's type of job and entrepreneurs spirit of students in Vocational High School; (4) there is no relationship between father's revenue rate and entrepreneur spirit of students in Vocational High School; (5) there is no relationship between mother's revenue rate and entrepreneur spirit of students in Vocational High School; and (6) there is no relationship between students' settlement and entrepreneur spirit of students in Vocational High School.
