Skripsi ini berjudul *Evaluasi Pelaksanaan Program Beras Miskin* studi kasus di Kecamatan Batur, Kecamatan Karangkobar, Kecamatan Kalibening, dan Kecamatan Wanayasa, Kabupaten Banjarnegara Jawa Tengah. Skripsi ini bertujuan untuk mengetahui apakah pelaksanaan Program Raskin sudah sesuai dengan ketentuan-ketentuan resmi mengenai Program Raskin yang dikeluarkan oleh BULOG.

Jenis penelitian ini adalah studi kasus dengan lokasi penelitian di Kecamatan Batur, Kecamatan Karangkobar, Kecamatan Kalibening, dan Kecamatan Wanayasa, Kabupaten Banjarnegara Jawa Tengah. Analisis yang digunakan adalah analisis deskriptif. Populasi penelitian adalah KK miskin yang menerima Raskin. Sampel yang diambil sebanyak 40 orang. Dalam pengambilan sampel, penulis memakai teknik *cluster sampling*. Pengambilan data dari responden dilakukan dengan kuesioner dan wawancara, data tersebut kemudian diinterpretasikan secara kualitatif.

Dari hasil penelitian dapat diambil kesimpulan bahwa : (a) Penerima beras miskin di Kabupaten Banjarnegara Jawa Tengah tidak tepat sasaran, (b) Penerima beras miskin tidak mendapatkan jatah beras miskin yang sesuai dengan ketentuan, (c) Pembayaran beras miskin telah sesuai aturan, (d) Pendistribusian beras miskin telah transparan, (e) Tugas dan wewenang pihak-pihak yang terkait telah terlihat sesuai ketentuan, (f) Sikap masyarakat miskin netral terhadap pelaksanaan Raskin. Hasil penelitian ini diharapkan dapat menjadi masukan bagi pemerintah kabupaten sampai pemerintah pusat dalam usaha memperbaiki kinerja pelaksanaan program beras miskin.

This subject of the research is *Evaluation On The Accomplishment Of Rice For The Poor Program (Raskin)* case study in Batur, Kalibening, Karangkobar, and Wanayasa, Banjarnegara Regency, Central Java. This research aims to find out whether or not the accomplishment of "Raskin" program has matched with the formal regulations of "Raskin" program from BULOG.

This research was a case study research located in Batur, Kalibening, Karangkobar, and Wanayasa, Banjarnegara Regency, Central Java. The data analysis that was used was descriptive analysis. The population research was poor family receiving "Raskin". 40 people were taken as the sample. In the sample gathering, the writer used cluster sampling techniques. The data collected from respondents used questionnaire and interviews, and the data was interpreted in a qualitative way.

From the research, the writer concluded that: (a) The program of rice for the poor in Banjarnegara Regency, Central Java did not reach the right target, (b) Recipients of rice for the poor did not obtain the sum of rice matched with the formal regulations, (c) Payment of rice for the poor has matched with the regulations, (d) Distribution rice for the poor has been transparent, (e) The tasks and authority involved in the program matched with the regulations, (f) The attitudes of poor society is neutral to the accomplishment of "Raskin". The results of this research is expected to give inputs to the government regency until central government to improve the working on the accomplishment of rice for the poor program.
