

## **ABSTRAK**

Dokumen Konsili Vatikan II menekankan bahwa kerasulan merupakan keterlibatan Gereja baik awam maupun religius untuk menyebarluaskan Kerajaan Allah, yang diwujudkan melalui berbagai bentuk atau model pelayanan demi kemuliaan Bapa dan keselamatan umat manusia. Dengan kegiatan merasul, baik rasul awam maupun biarawan-biarawati terlibat dalam pewartaan Kristus. Berdasarkan pemahaman tersebut, maka skripsi ini diberi judul: “KEPRIHATINAN RASULI DARI PENDIRI KONGREGASI CIJ TERHADAP HARKAT DAN MARTABAT KAUM PEREMPUAN DI ENDE-FLORES.”

Judul skripsi ini dipilih untuk menelusuri kembali semangat awal kerasulan pendiri dan pewarisannya kepada suster CIJ untuk mengangkat nilai dan martabat hidup manusia khususnya kaum perempuan, memperluas pemahaman dan penghayatan kerasulan Pendiri untuk dihidupi oleh suster CIJ dalam perutusan, meningkatkan semangat pelayanan suster CIJ kepada kaum perempuan melalui pendekatan pastoral, sosial dan kultural. Realitas menunjukan adanya pergeseran sikap dan semangat hidup untuk merasul secara efektif karena dipengaruhi oleh situasi zaman serta perkembangan ilmu dan teknologi. Maka penulis merasa perlu untuk memperhatikan dan meningkatkan Misi Gereja bagi keselamatan sesama, adanya kesadaran dan tanggung jawab penuh dari setiap anggota Gereja yang terpanggil untuk tugas pewartaan.

Untuk mencapai tujuan penulisan skripsi ini seperti yang diharapkan, penulis menggunakan pendekatan deskriptif analitis dengan menganalisis orientasi pastoral CIJ melalui Konstitusi Awal dalam studi kepustakaan dan beberapa sumber seperti dokumen-dokumen Gereja, dokumen-dokumen Kongregasi CIJ serta beberapa pustaka yang menunjang.

## ABSTRACT

Vatikan Second Document emphasizes that apostolate is an involvement of the Church, both lay people and religious wide spread the kingdom of God. And this is embodied through the various forms or models of ministry for the sake of the Father's glory and the salvation of mankind. By the apostolate, either lay apostle or religious man and women, are to involve in the proclamation of Christ. Based on the way of thinking mentioned above, then, this mini thesis is meant to be under the title of: **"APOSTOLIC CONCERN OF THE FOUNDER OF CIJ CONGREGATION TOWARD THE DIGNITY AND VALUE OF WOMEN IN ENDE-FLORES."**
