

ABSTRAK

Judul skripsi ini adalah **“Pemahaman Ajaran Sosial Gereja, khususnya Sollicitudo Rei Socialis Melalui Katekese Kontekstual Bagi Pengurus CU Hati Kudus di Paroki Santo Petrus Claver Bukittinggi Keuskupan Padang”**. Judul ini dipilih bertitik tolak dari tugas dan peranan yang diemban oleh pengurus CU khususnya pengurus CU Hati Kudus Bukittinggi dalam membantu meningkatkan perekonomian umat. Skripsi ini dimaksudkan untuk memberi gambaran tentang tugas dan peranan pengurus CU berdasarkan Anggaran Dasar dan Anggaran Rumah Tangga CU serta tanggapan Gereja terhadap keadaan sosial ekonomi masyarakat pada umumnya melalui Ajaran Sosial Gereja khususnya Sollicitudo Rei Socialis.

Permasalahan mendasar skripsi ini adalah bagaimana pengurus CU Hati Kudus Bukittinggi dapat melaksanakan tugas dan peranannya didalam membantu memperbaiki kesejahteraan hidup umat di Paroki St. Petrus Claver Bukittinggi dengan berlandaskan pada Ajaran Sosial Gereja, khususnya Sollicitudo Rei Socialis. Ajaran Sosial Gereja, khususnya Sollicitudo Rei Socialis ini dipahami melalui program katekese kontekstual yang dilaksanakan bagi pengurus CU Hati Kudus Bukittinggi.

Untuk memperoleh gambaran singkat mengenai skripsi ini, penulis menjelaskannya dalam lima bab. Pertama, pendahuluan. Kedua, gambaran umum Paroki St. Petrus Claver dan CU Hati Kudus Bukittinggi. ABSTRACT

The title of this thesis is “the Understanding of the Church Social Teachings, in Particular of the Sollicitude Rei Socialist through Contextual Catechism among the Officials of CU Hati Kudus in Parish Santo Petrus Claver Bukittinggi the Padang Bishopric”. The title was chosen for which the roles and duties being served by the CU officials especially by the CU Hati Kudus officials in Bukittinggi could help to enhance the congregation’s economy. For the purpose, this paper describes the roles and duties of CU officials in the basis of CU statutes and rules of associations, and the response of the church towards the conditions of social and economic condition of the people through the church social teachings in particular of the Sollicitude Rei Socialist.

The underlying problems of this writing is how the officials of CU Hati Kudus Bukittinggi could implement their roles and duties to better the congregation welfare in the Parish St. Petrus Claver Bukittinggi in the basis of the church social teachings in particular of the Sollicitude Rei Socialist. The church social teachings in particular of the Sollicitude Rei Socialist is understood by the contextual catechism held by the the officials of CU Hati Kudus Bukittinggi.

To find out the description, the writer elaborates it into five chapters. The first chapter contains the introduction. The second chapter includes the general picture of Parish St. Petrus Claver and CU Hati Kudus Bukittinggi. The third one discusses the church social teachings, in particular of the Sollicitude Rei Socialist and the roles and duties of the officials of CU Hati Kudus Bukittinggi. The fourth chapter explains the contextual catechism, and the last chapter ends with closings.
