

PLAGIAT MERUPAKAN TINDAKAN TIDAK TERPUJI

INTISARI

Pelayanan kefarmasiaan pada saat ini telah bergeser orientasinya dari obat ke pasien yang mengacu kepada pelayanan kefarmasian (*pharmaceutical care*). Kegiatan pelayanan kefarmasian yang semula hanya berfokus pada pengelolaan obat sebagai komoditi menjadi pelayanan komprehensif yang bertujuan untuk meningkatkan kualitas hidup dari pasien. Kepmenkes RI Nomor 1027/MENKES/SK/IX/2004 tentang standar pelayanan kefarmasian di apotek bertujuan sebagai pedoman praktik apoteker dalam menjalankan profesi serta melindungi masyarakat dari pelayanan yang tidak profesional dan melindungi profesi dalam menjalankan praktik kefarmasian

Penelitian ini bertujuan untuk mengetahui gambaran pelaksanaan Standar Pelayanan Kefarmasian berdasarkan Kepmenkes RI Nomor 1027/MENKES/SK/IX/2004 di apotek-apotek Kabupaten Bantul. Penelitian ini termasuk jenis penelitian non eksperimental dengan rancangan yang digunakan adalah deskriptif. Responden dalam penelitian ini adalah Apoteker Pengelola Apotek atau Apoteker Pendamping yang bersedia mengisi kuesioner yang merupakan instrumen penelitian ini. Analisis yang dilakukan adalah analisis deskriptif.

Hasil penelitian menunjukkan bahwa Standar Pelayanan Kefarmasian di Apotek berdasarkan Kepmenkes RI Nomor 1027/MENKES/SK/IX/2004 belum dilaksanakan secara menyeluruh oleh Apoteker di apotek-apotek Kabupaten Bantul

ABSTRACT

Pharmaceutical care orientation has changed from drug oriented to patient oriented which refers to pharmaceutical care. The Pharmaceutical care activities has, which previously only focused on the drugs management as a commodity, become more focused in to a comprehensive care that aimed at increasing the quality of patient's life. Kepmenkes RI Number 1027/MENKES/SK/IX/2004 about Pharmaceutical Care Standards in Dispensary aims at as guidance of pharmacist practice in performing the profession and also protects society of service which is not professional and protects profession in pharmacy practice.

This research aimed at knowing the description of the implementation of Pharmaceutical Care Standards based on the Kepmenkes RI Number 1027/MENKES/SK/IX/2004 in dispensaries in Bantul. This research was non eksperimental research type in which the device used was descriptive. This respondents of this research were Administrator Pharmacist or Co-Pharmacist that willingly filled in the questionnaire which was the instrument of the research. The analysis performed was descriptive statistic.

The result of the study showed that the Pharmaceutical Care Standards in Dispensary based on the Kepmenkes RI No. 1027/MENKES/SK/IX/2004 in Bantul was not well performed yet by pharmacists in dispensaries in Bantul.
