

ABSTRAK

Penelitian ini mengkaji tentang elemen pokok dan pelengkap wacana argumentasi dalam artikel harian Tribun Jogja kolom opini. Tujuan penelitian ini adalah (1) mendeskripsikan bentuk-bentuk elemen pokok wacana argumentasi, (2) mendeskripsikan bentuk-bentuk elemen pelengkap wacana argumentasi, dan (3) mendeskripsikan pola elemen pengembangan wacana argumentasi pada artikel yang dimuat di harian Tribun Jogja.

Jenis penelitian ini adalah deskriptif kualitatif. Data yang digunakan dalam penelitian ini berupa wacana dalam artikel harian Tribun Jogja kolom opini periode januari – april 2015. Prosedur pengumpulan data dalam penelitian ini dilakukan dengan teknik observasi (baca dan catat).

Hasil penelitian menunjukkan bahwa (1) elemen pokok yang ditemukan dalam artikel harian Tribun Jogja kolom opini berupa elemen pernyataan, alasan dan pemberian. Ketiganya terdapat dalam setiap wacana, (2) elemen pelengkap yang ditemukan adalah elemen pendukung, modal, dan sanggahan, namun tidak semua elemen tersebut terdapat di setiap wacana, (3) pola pengembangan wacana argumentasi ada enam macam. Tiga macam pola terdiri dari elemen pokok dengan dua elemen pelengkap, yaitu (PER-AL-PEM-PEN-MO), (PER-AL-PEM-MO-SA), dan (PER-AL-PEM-PEN-SA). Tiga macam pola lainnya terdiri dari elemen pokok dengan satu elemen pelengkap, yaitu (PER-AL-PEM-PEN), (PER-AL-PEM-MO), dan (PER-AL-PEM-SA).

This research examined the main and complementary elements in argumentative passages in the opinion column of Tribun Jogja Newspaper. This research was aimed to (1) describe kinds of main elements in argumentative passages, (2) describe kinds of complementary elements in argumentative passages, and (3) describe the development patterns of the argumentative passages in the articles written in Tribun Jogja Newspaper.

This research was a descriptive qualitative research. The data used in this research were in the forms of passages written in the articles of opinion column Tribun Jogja Newspaper January – April 2015 issues. The data used in this research were collected by conducting observations (reading and note-taking).

The results of this research showed that (1) the main elements found in articles of opinion columns Tribun Jogja Newspaper were in the forms of statements, reasons, and justifications. The all three were found in every passage, (2) the complementary elements found were supporting, auxiliary, and objection elements. But, not all of those elements were found in each passage, (3) there were six kinds of development patterns. Three patterns consisted of a main element and two complimentary elements, i.e. (PER-AL-PEM-PEN-MO), (PER-AL-PEM-MO-SA), an (PER-AL-PEM-PEN-SA). Three other patterns consisted of a main element and one complimentary element, i.e. (PER-AL-PEM-PEN), (PER-AL-PEM-MO), and (PER-AL-PEM-SA).
