

ABSTRAK

Penelitian ini membahas mengenai ambiguitas dalam peristiwa tutur dialog interaktif Indonesia *Lawyers Club* periode Juli—September 2019. Penelitian ini memiliki rumusan masalah utama, yaitu ambiguitas yang terjadi pada peristiwa tutur dialog interaktif Indonesia *Lawyers Club* periode Juli—September 2019. Dari rumusan masalah utama tersebut peneliti menjabarkan dua sub rumusan masalah, yaitu ambiguitas pada makna dalam peristiwa tutur dialog interaktif, dan ambiguitas pada diksi dalam peristiwa tutur dialog interaktif Indonesia *Lawyers Club* periode Juli—September 2019.

Tujuan penelitian dari rumusan masalah utama adalah mendeskripsikan ambiguitas yang terdapat dalam peristiwa tutur dialog interaktif. Lalu, peneliti menjabarkan tujuan penelitian berdasarkan sub masalah, yaitu mendeskripsikan ambiguitas pada makna dalam peristiwa tutur dialog interaktif dan mendeskripsikan ambiguitas pada diksi dalam peristiwa tutur dialog interaktif Indonesia *Lawyers Club* periode Juli—September 2019

Jenis Penelitian ini merupakan penelitian kualitatif dengan sumber data yang diambil dari tanggal 20 April—27 Juni 2020 melalui video unggahan di *Youtube* mengenai dialog interaktif Indonesia *Lawyers Club* periode Juli—September 2019. Metode yang digunakan dalam penelitian ini adalah metode simak. Teknik pengumpulan data yang digunakan peneliti adalah simak dan catat. Selain itu, teknik analisis data yang digunakan oleh peneliti yaitu, menyeleksi data, menganalisis, mendeskripsikan, memaparkan hasil penelitian, dan membuat kesimpulan.

Berdasarkan rumusan masalah diatas, hasil yang diperoleh peneliti adalah empat puluh satu data tuturan yang dianalisis. Hasil data pada rumusan masalah utama, yaitu berupa ambiguitas fonetik, gramatikal, dan leksikal. Lalu peneliti memperoleh data dari sub rumusan masalah, yaitu ambiguitas pada makna dalam peristiwa tutur dialog interaktif, yaitu konotatif dan makna nonreferensial, serta ambiguitas pada diksi dalam peristiwa tutur dialog interaktif, yaitu polisemi, homonim, dan sinonim.

ABSTRACT

This research discusses ambiguity in the interactive dialogue speech events of the Indonesia Lawyers Club for the period July—September 2019. This research has a formulation of the main problem, namely the ambiguity that occurs in the interactive dialogue speech events of the Indonesia Lawyers Club for the period July—September 2019. Describes two sub-problem formulations, namely ambiguity in meaning in interactive dialogue speech events, and ambiguity in diction in the interactive dialogue speech event of the Indonesia Lawyers Club for the July - September 2019 period.

The research objective of the formulation of the main problem is to describe the ambiguity in interactive dialogue speech events. Then, the researcher described the research objectives based on the sub-problem, namely describing the ambiguity in the meaning in interactive dialogue speech events and describing the ambiguity in diction in the interactive dialogue program of the Indonesia Lawyers Club for the July - September 2019 period.

This type of research is a qualitative research with data sources taken from 20 April —7 June 2020 through uploaded videos on Youtube regarding the interactive dialogue of the Indonesia Lawyers Club for the period July - September 2019. The method used in this research is the observation method. The data technique used by the researcher was listening and taking notes. In addition, the data analysis techniques used by researchers were selecting data, analyzing, describing, explaining the results of the research, and making conclusions.

Based on the formulation of the problem above, the results obtained by the researcher were forty-one speech data analyzed. The results of the data on the formulation of the main problem, namely in the form of phonetic, grammatical, and lexical ambiguities. Then the researcher obtained data from the sub-problem formulation, namely ambiguity in the meaning in interactive dialogue speech events, namely connotative and non-referential meanings, as well as ambiguity in diction in interactive dialogue events, namely polysemy, homonym, and synonym.
