Penerapan asas-asas *Good Corporate Governance* (GCG) menjadi suatu poin yang penting bagi perusahaan-perusahaan di Indonesia untuk mampu bertahan dan bertumbuh sekaligus untuk menumbuhkan kepercayaan dan keberlanjutan. Penelitian ini bertujuan untuk mendeskripsikan penerapan asas-asas *Good Corporate Governance* di PT. Agro Abadi Cemerlang.

Jenis penelitian ini adalah studi kasus. Teknik pengumpulan data yang dilakukan dalam penelitian ini adalah wawancara dan dokumentasi. Teknik analisis data yang digunakan adalah reduksi data, penyajian data, dan penarikan kesimpulan.

Hasil penelitian menunjukkan bahwa pada asas transparansi, perusahaan menyampaikan dan mengungkapkan informasi secara transparan kepada pihak internal perusahaan yaitu karyawan. Pada asas akuntabilitas, perusahaan memiliki sistem pengendalian internal, struktur organisasi, rincian tugas yang jelas. Pada asas responsibilitas, perusahaan telah melaksanakan *corporate social responsibility*, dan telah mematuhi peraturan pemerintah. Pada asas independensi, perusahaan dikelola secara professional dan tidak ada dominasi dari pihak lain. Pada asas kewajaran dan kesetaraan, setiap pemangku kepentingan dalam perusahaan mendapatkan hak dan perlakuan yang sama.
