

EVALUASI KUALITAS PSIKOMETRI INVENTORI *COLLECTIVIST COPING STYLES* (CCS) VERSI BAHASA INDONESIA UNTUK MAHASISWA INDONESIA

ABSTRAK

Inventori *Collectivist Coping Style* (CCS) merupakan alat ukur yang secara khusus dikembangkan untuk mengukur bentuk *coping* yang digunakan dan membantu masyarakat kolektif menyelesaikan masalahnya. Inventori CCS memiliki lima sub-skala yang terdiri dari (a) *Acceptance, Reframing, and Striving*, (b) *Family Support*, (c) *Religion-Spirituality*, (d) *Avoidance and Detachment*, dan (e) *Private Emotional Outlets*. Penelitian ini bertujuan untuk memeriksa kualitas psikometri Inventori CCS yang meliputi kualitas item, reliabilitas skor, bukti validitas isi, dan bukti validitas terkait dengan struktur internal. Pengumpulan data dilakukan dengan menyebarkan Inventori CCS yang sudah diterjemahkan ke dalam Bahasa Indonesia secara *online* melalui *Google Form*. Sampel sebesar 443 partisipan dipilih dengan menggunakan teknik *convenience sampling*. Kualitas item dalam penelitian ini diperiksa dengan melihat nilai korelasi item total dan *if omega item-dropped*, dengan hasil yang menunjukkan jika item A11 pada sub-skala ARS memiliki nilai korelasi item-total yang sedikit berada di bawah nilai ideal ($r = 0.288$), tetapi tidak dapat dikatakan sangat buruk untuk bisa digugurkan. Reliabilitas masing-masing sub-skala diestimasi menggunakan pendekatan *Omega McDonald*. Hasil menunjukkan kelima sub-skala CCS memiliki nilai reliabilitas yang cukup ideal dalam rentangan nilai 0.762 sampai 0.815 dan konsisten dibandingkan dengan penelitian-penelitian sebelumnya. Terakhir, validitas isi diperiksa dengan melakukan *expert review*, sedangkan bukti validitas terkait dengan struktur internal diperiksa dengan menggunakan *confirmatory faktor analysis* (CFA) dengan hasil yang menunjukkan jika model lima faktor CCS memiliki nilai indeks yang fit, didukung oleh data.

EVALUATION OF THE PSYCHOMETRIC QUALITY OF THE INDONESIAN VERSION OF THE COLLECTIVIST COPING STYLES (CCS) INVENTORY FOR INDONESIAN UNIVERSITY STUDENTS

ABSTRACT

Collectivist Coping Style Inventory (CCS) is an instrument specifically developed to measure coping style of a person in collectivist communities when he/she face a stressful situation. CCS Inventory, consists of five dimensions : (a) Acceptance, Reframing, and Striving, (b) Family Support, (c) Religion-Spirituality, (d) Avoidance and Detachment, and (e) Private Emotional Outlets. The purposed of current study was to examine the psychometric quality of the CCS Inventory, including inventory items quality, scores reliability, evidence of validity based on content, and evidence of validity based on its internal structures. Data was collected by distributing the translated CCD Inventory into Indonesia, using Google Forms. The sample was collected using convenience sampling technique and consisted of 443 students as partisipants. The quality of the items in this study was examined by looking at the item-total correlation value and *if omega item-dropped*, with the results showing that item A11 on the ARS sub-scale has an item-total correlation value that is slightly below the ideal value ($r = 0.288$), but it cannot be said to be so bad that it can be dropped . The reliability of each subscale was estimated using *Mcdonald's Omega* approach . Results showed that the five CCS subscales had ideal reliability values in the range of 0.762 to 0.815 and were consistent compared to previous studies. Finally, content validity was examined by conducting an *expert review*, while validity evidence related to internal structure was examined using *confirmatory factor analysis* (CFA) with results indicating that the five-factor model of the CCS has fit index values, supported by the data.
