Penelitian ini bertujuan untuk mengevaluasi implementasi prinsip-prinsip *Good Corporate Governance (GCG)* pada PT Bank NTT Cabang Lewoleba, Lembata, Nusa Tenggara Timur. Tujuan utama penelitian ini adalah mengukur kualitas penerapan Good Corporate Governance, mengidentifikasi kekuatan dan kelemahan implementasinya, serta memberikan rekomendasi perbaikan guna meningkatkan efektivitas tata kelola perusahaan.

Jenis penelitian ini adalah studi kasus. Data-data yang diperoleh dengan melakukan penyebaran kuesioner dan dokumentasi. Teknik analisis data yang digunakan adalah dengan menggunakan metode deskriptif kualitatif

Hasil penelitian menunjukkan bahwa implementasi prinsip *Good Corporate Governance (GCG)* pada PT Bank NTT Cabang Lewoleba yang mendapatkan kategori sangat terwujud dengan persentase sebagai berikut: prinsip transparansi mencapai 96,30%, akuntabilitas 98,89%, pertanggungjawaban 98,15%, kemandirian 94,44%, serta kewajaran 98,15%.

This study aims to evaluate the implementation of Good Corporate Governance (GCG) principles at PT Bank NTT Lewoleba Branch, Lembata, East Nusa Tenggara. The main objective of this research is to measure the quality of the implementation of Good Corporate Governance, identify the strengths and weaknesses of its implementation, and provide recommendations for improvement to increase the effectiveness of corporate governance.

This type of research was a case study. Data were obtained by distributing questionnaires and documentation. The data analysis technique used was descriptive qualitative method.
