This research was aimed to find out (1) financial performance of "PT Kedaung Indah Can Tbk, PT Kedawung Setia Industrial Tbk and PT Langgeng Makmur Plastic Tbk" viewed from liquidity, solvability, activity and profitability aspect from 1999 to 2003 (2) financial performance of "PT Kedaung Indah Can Tbk, PT Kedawung Setia Industrial Tbk and PT Langgeng Makmur Plastic Tbk" viewed from adequacy and efficiency of cash flows from 1999 to 2003 (3) comparison of financial performance among "PT Kedaung Indah Can Tbk, PT Kedawung Setia Industrial Tbk and PT Langgeng Makmur Plastic Tbk" from 1999 to 2003.

This research was conducted at "Pojok BEJ" Sanata Dharma University on May 2005. The technique of the data collecting used was documentation. The technique of the data analyzing used were vertical analysis and horizontal analysis with the use of an evaluation benchmark of industry ratio.

The result of this research showed that (1) viewed from liquidity
