Patient safety is a responsibility of health care team. Medication error is closely related to patient safety. Medication error is an error occurs within the process of therapy and under supervision of health care team. Medication error potentially occurs during the process of non-verbal communication between pharmacist and medical doctor through a prescription. As a communication media between pharmacist and doctor, a precise transcription of a prescription must be assured. Therefore, a prescription must contain any information which are essential, such as patient's identity, doctor's identity, also age and body weight of the patient for dose calculation. Furthermore, the doctor's handwriting must meet legibility aspect to be transcribed. However, such those conditions are not always fulfilled. Therefore, this study aimed at exploring doctor's views regarding information must be provided in a prescription to avoid medication error. This study involved 93 doctors in hospitals and private practice in Yogyakarta and Surakarta who were selected non-random conveniently. Data were gathered through interviews using an interview guideline. Results of this study show an interesting view that more than half participants tend to agree to the provision of patient's body weight information in a prescription (55%), while 30% of them are neither agree nor disagree, and 15% are disagree. The dominant reason why they did not agree to always provide patient's body weight information is that such an information is not essential for adult patients, except pediatric patients. They also stated that patient's address should not be written by prescriber as such an information is not related to process of therapy; it should be written by pharmacists. Most of them agree that doctor's handwriting must be readable.
