Some Notes on Indonesian Word Formation: A Study Based on the Derivational Morphology Approach

Abstract: This study aimed to provide an in-depth analysis of the complex process of word formation in the Indonesian language using the principles of derivational morphology. The study examined the intricate mechanisms of creating new words and highlighted the various processes and patterns that contributed to forming new lexemes. By extensively categorizing and analyzing the different types of derivational affixes and their roles in generating words, this investigation aimed to contribute to a deeper understanding of the Indonesian language and its linguistic evolution. The findings showed (1) the intricate details regarding the changes in the use of affixes such as in prefix {di-} and colloquial suffix {al-}, the semantic transformation of words such as the words that were marked by prefix {per-}, and how societal attitudes and perceptions had influenced language evolution such as in colloquial suffix {-ken} despite the standard suffix {-kan}; and (2) the functions and communicative effectiveness of derived lexemes in the Indonesian language had revealed that they played a crucial role in communication by contributing to discourse cohesion such as in the form of {seru} and {menarik}. The results of this study were expected to shed new light on the underlying mechanisms of word formation in the Indonesian language and provide a valuable reference for linguists and language researchers to explore the nuances of this language further.

Keywords: Indonesian Language, Word Formation, Derivational Morphology, Affixation, Lexical Derivation, Morphological Processes.

INTRODUCTION

The field of linguistics has always been fascinating for its ability to uncover the nuances of language and how it has evolved. Word formation holds a pivotal role in understanding the structure of a language among the various areas of study in linguistics (Borer, 2017; Chomsky, 2015; Embick, 2013; Kiparsky, 2012; Luschützky, 2015; Raffelsiefen, 2015; Taylor, 2015). Delving deeper into this area, this research explores the Indonesian language's word formation, explicitly focusing on derivational morphology - the process of forming new words by adding prefixes or suffixes to existing words (Nugraha, 2018a, 2018c, 2018b, 2018d, 2020b). Through this study, we aim to unravel the complexities of Indonesian language pseudo-evolution, uncovering the intricate fabric of language construction and enriching our understanding of this beautiful language. The main objective of this research is to delve deeper into the intricacies of word formation and to shed light on its significance in linguistic theory and application. A thorough examination of derivational affixes and their functions forms the crux of this study, with the ultimate aim of establishing a solid foundation of knowledge on Indonesian morphology. The insights gained from this research are expected to serve as a valuable resource for future linguistics and language studies, providing a direction for further exploration and analysis of this complex subject matter.

The Indonesian language is known for its rich nuances and cultural influences, making it an exciting terrain to explore when analyzing the mechanisms that govern word creation (Nugraha, 2020c, 2022b, 2023b, 2023c; Pasaribu & Nugraha, 2020). In this study, we aim to delve deeper into the processes that lead to the emergence of new words within the Indonesian linguistic framework. We will be utilizing a derivational morphology approach (Jacques, 2012), enabling

us to examine the different affixation patterns used, as well as their respective roles and contributions towards the expansion and evolution of the Indonesian lexicon. With this research, the theoretical framework of this research is based on the idea that understanding the morphological structure of Indonesian words and the processes involved in their formation is critical for comprehending the language's lexicon. By analyzing the works of scholars such as (Fradin, 2020; Lieber *et al.*, 2015; Spencer, 2015; Štekauer, 2015), we can gain significant insights into the mechanisms of word formation in Indonesian, which can help us better understand the language and its cultural context.

The study of derivational morphology, a vital aspect of linguistic inquiry, has been extensively researched across various language frameworks (Schmid, 2015; Stekauer *et al.*, 2012). Scholars in Indonesian linguistics have explored the complexities of word formation, offering insights into the multifaceted processes that shape the Indonesian lexicon. One crucial aspect of this exploration is the works of renowned linguists such as scholars such as Sneddon *et al.*, (2012) and Anceaux (1961). Sneddon *et al.*'s groundbreaking research on Indonesian morphology provided a foundational understanding of the intricate interplay between affixation and lexeme creation within the language. Their in-depth analysis of affixation patterns and their semantic nuances offered a starting point for subsequent investigations into Indonesian word formation. In addition, Anceaux is a who has also made contributions to the field of derivational morphology. He built upon the other work of analysis and delved deeper into the mechanisms of creating new words in the Indonesian language. His thorough analysis of various affixes, including their historical origins and roles in word formation, has provided a more nuanced understanding of the expansion of the Indonesian lexicon. Moreover, in linguistics, there has been a growing interest in applying computational models to analyze the morphology of the Indonesian language.

In recent years, scholars such as Nugraha (2017a, 2020a, 2021b, 2021a, 2022a) have made notable contributions to this area of research by combining computational linguistics with traditional morphological studies. This has paved the way for a deeper understanding of the complex processes involved in word formation in Indonesian and has introduced innovative methodologies for analyzing derivational processes. This rich and diverse body of scholarship is the foundation for the present research on Indonesian word formation. Drawing upon the various strands of literature (Bauer, 2002; Bonami & Strnadová, 2019; Körtvélyessy *et al.*, 2020; Melloni & Dal Maso, 2022a), this study aims to synthesize and expand upon existing knowledge to shed light on the underlying mechanisms of derivational morphology in Indonesian. Through this exploration, we aim to further our understanding of the complexities of the Indonesian language and contribute to the advancement of linguistic research. Although previous research has made significant strides in our comprehension of derivational processes within Indonesian, there is a need for a more nuanced analysis of the socio-cultural influences on word formation. The impact of socio-cultural factors, such as historical events, linguistic borrowing, and societal changes, on the evolution of derivational morphology in Indonesian remains an area that needs further exploration. Moreover, a comprehensive investigation into the communicative aspects of newly formed lexemes within Indonesian has yet to be fully pursued.

The current state of research on Indonesian word formation through derivational morphology suggests a significant gap in our understanding of the topic. To address this gap, it is necessary to take a more comprehensive approach that considers the socio-cultural influences that shape the language, the functionalities it serves, and the advanced computational methodologies that can help us better analyze and comprehend its complexities. By integrating these different perspectives and methods, we can gain a more nuanced and holistic understanding of how Indonesian words are formed through derivational morphology and how they function within the broader linguistic and cultural context. Accordingly, the research questions are (1) what is the impact of socio-cultural factors, such as historical influences and linguistic borrowings, on the processes of derivational morphology in the Indonesian language; specifically, how do these factors affect the formation of new words through affixation and other morphological processes; and (2) what are these newly formed lexemes' functions and communicative effectiveness in different societal domains within Indonesia?

METHODOLOGY

The study's main objective was to explore the socio-cultural factors that influenced the formation of new words in Indonesian. To achieve this, qualitative methodological approaches and techniques were integrated. This research design helped gain a thorough understanding of the formation of new lexemes and their communicative efficacy. The research offered valuable insights into the underlying mechanisms and social factors that played a role in word formation in the Indonesian language.

As the first phase of research, it was the procedure for dealing with the first research question concerning the understanding of the influence of socio-cultural factors. An approach was employed to thoroughly investigate the effects of socio-cultural factors on derivational morphology in Indonesian word formation. This approach involved research methods to understand better the evolution of specific affixes and word formations within the Indonesian language. First, a comprehensive analysis examined texts, linguistic archives, and records; as in the Indonesian corpus, namely *Indonesian – Leipzig Corpora Collection (ILCC)* (https://corpora.unileipzig.de/en?corpusId=ind_mixed_2013). This step allowed for the tracing of the evolution of specific affixes and word formations within the Indonesian language and an understanding

of how socio-cultural factors influenced them over time. Through this analysis, instances of linguistic borrowings, semantic shifts, and affix usage in different periods were identified, and their relationship with socio-cultural factors was examined. Lastly, language experts, native speakers, and were interviewed and surveyed; namely ADKS (F) and LAS (F). This qualitative data helped to understand the perceived socio-cultural influences on word creation and derivational morphology. By combining these research methods, a comprehensive understanding of socio-cultural factors' impact on Indonesian word formation and derivational morphology was gained.

The second phase of research was analyzing functions and communicative efficacy. The study aimed to delve deeper into newly created lexemes' practical functions and communicative efficacy. To achieve this, the following methodologies were employed: Firstly, contextual analysis was used to scrutinize the contextual usage of derived words in authentic settings such as conversations, written texts, and specialized domains (e.g., sciences, arts, technology). The aim was to discern the functions of these newly formed lexemes and their appropriateness in different communicative contexts. By examining their usage in different settings, we hoped to identify patterns of use that may shed light on their intended meanings and the communicative functions they serve. Secondly, discourse analysis techniques were employed to investigate how these newly formed lexemes contributed to the coherence and cohesion of discourse in various societal domains. We assessed their impact on conveying precise meanings and facilitating effective communication. Through this approach, we would better understand how these newly formed words functioned in different contexts and how they may be used to enhance effective communication.

Lastly, based on the research process comprising two phases, the results obtained from both phases were cross-referenced and verified by utilizing the theoretical linguistics framework, particularly the derivational morphology approach. The research outcomes were then meticulously analyzed, presented, and discussed in detail in this article. The rigorous methodology employed in this study ensured the accuracy and reliability of the conclusions drawn, which can be beneficial for further research in this field.

RESULTS

The Impact of Socio-cultural Factors on The Processes of Derivational Morphology in The Indonesian

The study's findings offer a thorough and nuanced comprehension of how various socio-cultural factors have impacted the development and evolution of word formation in Indonesia. The research delves into intricate details regarding the changes in the use of affixes, the semantic transformation of words, and how societal attitudes and perceptions have influenced language evolution. The research outcomes provide a comprehensive and illuminating understanding of Indonesia's intricate interplay between language, culture, and society. The results provide a comprehensive understanding of how socio-cultural factors have influenced the historical trajectory of Indonesian word formation, shedding light on shifts in affix usage, semantic evolution, and societal perceptions regarding language evolution.

The first step in analyzing the Indonesian derivational morphology is to conduct a semi-historical analysis. This involves identifying significant shifts in affix usage and semantic changes over different historical periods (*see* Excerpt 1). By examining the evolution of specific affixes across time, we can establish connections between historical events, linguistic borrowings, and the development of Indonesian derivational morphology. By tracing the origins and changes in affix usage, we can better understand the historical context in which the language has evolved and how external factors have influenced it. This type of analysis is crucial in uncovering the underlying patterns and trends that have shaped the Indonesian language over time. It can provide valuable insights into its current state and future development.

The study of language evolution has always been an important field of research, with morphology and word formation being some of the most fascinating aspects of this area. In particular, the study of affix usage has provided valuable insights into the historical development of language (*see* Excerpt 2). This involves detailed documentation of significant shifts in the utilization of affixes across different historical epochs, revealing periods of adoption, adaptation, and abandonment of specific morphological elements. Another important aspect of language evolution is semantic change, which involves identifying semantic changes and extensions of affix meanings over time. This showcases how socio-cultural factors influenced alterations in word meanings and formations. For instance, the meanings of certain affixes may shift with time, leading to new words and word meanings (*see* Excerpt 3). Furthermore, genre-specific affix usage is an essential area of study that can provide insights into how specific socio-cultural contexts favor particular affixes or derivational patterns. For example, specific genres may prefer certain affixes for creating words that reflect a specific tone or convey a particular meaning. By examining how different genres utilize affixes, we can better understand how language evolves and adapts to different cultural contexts.

(1) Excerpt 1

Aspect: Semantic Evolution of Affixes

Construction: {di-} (Prefix)

Sample sentence: "*Anda harus menyiapkan argumen ilmiah **di** segala sisi untuk mengawalinya.*" (You have to prepare scientific arguments on all sides to support it.)

Example: In Indonesian, the prefix {di-} originally had a specific function of denoting PASSIVE voice in a sentence. However, as the language evolved, this prefix began to take on additional meanings beyond its original purpose. The prefix expanded its usage to indicate the subject's LOCATION or EXISTENCE in a sentence. This semantic broadening resulted from increased trade interactions and cultural exchanges, which brought with them a shift in socio-cultural norms and practices. As a result, nuances of LOCATION and EXISTENCE gained prominence in the language, reflecting the changes in society. This shift in the prefix {di-} meaning highlights the intricate relationship between language and culture, where linguistic changes often mirror social and cultural changes.

(2) Excerpt 2

Aspect: Correlation with Historical Events

Construction: {per-} (Prefix)

Sample sentence: "*Setelah Wong Agung Wilis tertangkap **perjuangan** melawan VOC dilanjutkan olehnya.*" (After Wong Agung Wilis was captured, he continued the struggle against the VOC.)

Example: The 20th century was a period of significant socio-political change in Indonesia, marked by the emergence of nationalist movements that sought to unite the diverse society under a common cause. During this time, the prefix {per-} gained immense popularity, as it provided a linguistic tool to indicate collective action and solidarity. This prefix was particularly useful in Indonesia, where diverse ethnic and linguistic groups often struggled to find common ground. The use of {per-} surged during this period, reflecting the growing aspirations of Indonesian society for unity and cooperation. Adopting this prefix in everyday language was a testament to the linguistic response to Indonesia's changing social and political landscape, and its impact on the country's culture and identity cannot be overstated.

(3) Excerpt 3

Aspect: Adaptation of Loanwords and Affixes

Construction: {al-} (Prefix)

Sample sentence: "*Disinilah dibutuhkan semangat **al-hikmah**, yang salah satu maknanya berarti kearifan untuk meneliti dan membuktikan itu semua.*" (This is where the spirit of al-hikmah is needed, one of the meanings of which is the wisdom to research and prove it all.)

Example: The Indonesian language has undergone extensive adaptation in terms of affixes, particularly by incorporating elements from other languages such as Sanskrit and Arabic. These linguistic assimilations are an apt reflection of the country's cultural borrowings. The inclusion of Arabic-derived affixes such as {al-} in the Indonesian language serves as a testimony to the profound influence of the Islamic world on the country's socio-cultural fabric. The assimilation of foreign affixes into the Indonesian language is an example of how language evolves and adapts to socio-cultural exchanges, mirroring the development of the society it represents.

Various socio-cultural factors have significantly influenced the semantic evolution of affixes in Indonesian morphology. These factors have played a crucial role in shaping how affixes have evolved, often correlating with historical events and facilitating the adaptation of loanwords into the language's morphology. The result is a complex interplay between language evolution and socio-cultural dynamics, highlighting the intricate relationship between language and culture. These examples serve as a testament to the fascinating ways language can be shaped by the culture in which it is used. These examples illustrate how socio-cultural factors have influenced the semantic evolution of affixes, correlated with historical events, and facilitated the adaptation of loanwords into Indonesian morphology, highlighting the intricate interplay between language evolution and socio-cultural dynamics.

Furthermore, the second phase of our research project involves conducting interviews and surveys to gather qualitative insights about the perceptions and experiences of individuals regarding socio-cultural influences on language evolution. Through this process, we aim to explore the emergence of socio-cultural themes that impact derivational morphology. The research project consists of two main components investigating the evolution of Indonesian derivational morphology. The first component is expert perspectives, which involves detailed insights from linguists and cultural experts (*see* Excerpt 4). They will share their knowledge and expertise on the impact of historical events, societal changes, and cultural interactions on the evolution of Indonesian derivational morphology. Their findings will provide a deeper understanding of how the language has developed over time and the factors that have influenced its evolution.

The second component is public perception, which involves gathering diverse opinions and experiences from survey respondents (*see* Excerpt 5). This component aims to reveal societal perceptions regarding the influence of socio-cultural factors on language evolution. This component will showcase how these factors affect word creation and usage in everyday life. The survey will cover a wide range of topics, including the use of slang, the influence of foreign languages, and the impact of technology on language use. The findings from this component will provide insights into how language is shaped by the people who use it and the social and cultural context in which it is used.

(4) Excerpt 4

Aspect: Insights on Socio-Cultural Influences

Construction: {-ken} Suffix

Sample sentence: "**Silahkan lanjutkan** untuk belajar bertanya dan belajar menjawab." (Please continue to learn to ask and learn to answer.)

Direct quotations of experts: "*Pak Harto selalu menggunakan akhiran {-ken} karena terbiasa. Kebiasaan itu terjadi karena di lingkungan tertentu terdapat kebiasaan tersebut (mengucapkan {-ken}) sehingga seolah-olah sudah menjadi "dialek lokal" yang menurut mereka itu adalah benar.*" (ADKS, F-39)

(Pak Harto always uses the ending {-ken} because he is used to it. This habit occurs because in certain environments there is this habit (of saying {-ken}) so it seems as if it has become a "local dialect" which they think is correct.)

(5) Excerpt 5

Aspect: Insights on Socio-Cultural Influences

Construction: {-ken} Suffix

Sample sentence: "**Untuk afdolnya silahkan lakukan** percobaan sebagai berikut." (To complete it, please carry out the experiment as follows.)

Direct quotations of experts: "*Karena saya guru Bahasa Indonesia, ya memberi tahu ke murid-murid bahwa itu tidak sesuai dengan EYD (Ejaan Yang Disempurnakan; kaidah yang saat itu berlaku)...Pak Presiden menggunakan akhiran {-ken} hanya untuk mengakrabkan diri dan menunjukkan salah satu ciri pribadinya...Jadi ya biasa saja...namun tidak boleh ditiru...agar tdk merusak EYD.*" (LAS, F-64)

(Because I am an Indonesian teacher, I told the students that it was not in accordance with EYD (*Ejaan Yang Disempurnakan*; the rules that were in force at that time)...Mr President uses the ending {-ken} just to familiarize himself and show one of the characteristics personal... So yes, it's normal... but it shouldn't be imitated... so as not to damage EYD.)
